



# OCEAN BEACH PLANNING BOARD ELECTION 2009 CANDIDATE MATERIALS

## General Information

- Election will be held Tuesday, March 10th, 2009 from 4:00pm to 7:30pm at the Ocean Beach Recreation Center, 4726 Santa Monica Avenue.
- Term length is two years. Serving the Community by sitting on the Ocean Beach Planning Board is a Volunteer position, not a paid position. A labor of love for OB!
- Meetings are held on the first and third Wednesdays of each month at the Ocean Beach Recreation Center, 4726 Santa Monica Ave. The first Wednesday meeting is the General Meeting from 6:00pm-8:00pm and the third Wednesday is the Project Review Committee Meeting from 6:30pm-8:00pm.
- Community Members are eligible to run for election in their district provided that they are 18 years of age, have attended at least one OBPB General Meeting prior to March 4<sup>th</sup>, 2009, and meet at least one of the following criteria within their district: 1. 30-day resident; 2. Property owner; 3. Business licensee.

## Procedural Information

**Step 1:** Read the attached materials.

**Step 2:** Examine the attached map for District boundaries to determine the District number for which you qualify to run for election.

**Step 3:** Complete the attached affidavit.

**Step 4:** Obtain 35 valid nomination petition signatures from the District for which you will represent. **ALL** boxes on attached nomination petition form must be filled in for signature to be considered valid. Personal information will not be shared by OBPB Election Committee.

**Step 5:** Must attend at least one OBPB General Meeting prior to March 4<sup>th</sup>, 2009.

**Step 6:** Submit your completed Election 2009 Candidate Materials to the Ocean Beach Planning Board by one of the following three methods: 1. Mailed to the Ocean Beach Planning Board (OBPB) P.O. Box 7090, Ocean Beach, CA, 92167; 2. Served at a Planning Board meeting (1<sup>st</sup> and 3<sup>rd</sup> Wednesdays, Ocean Beach Recreation Center, 4726 Santa Monica Ave, from 6:00pm-8:00pm on the 1<sup>st</sup> Wednesday and 6:30pm-8:00pm on the 3<sup>rd</sup> Wednesday); 3. Served to a member of the OBPB Election Committee. In order to qualify to run for election to the Board you must return the affidavit and the attached petition with 35 valid signatures of 30-day residents, property owners and/or business licensees within the district for which you will represent, prior to 6:00 pm on Sunday, February 8th, 2009 – 30 days prior to the election. The addresses and signatures will be verified and you will be notified if your name is qualified for the ballot. The election will be held on Tuesday, March 10th, 2009 from 4:00pm-7:30pm at the Ocean Beach Recreation Center, 4726 Santa Monica Avenue.

You may return your completed affidavit and petition at any Board meeting prior to February 8th, 2009, regularly held on the first and third Wednesdays of the month at the Ocean Beach Recreation Center, 4726 Santa Monica Avenue. Meetings are held from 6:00pm-8:00pm on the 1<sup>st</sup> Wednesday and 6:30pm-8:00pm on the 3<sup>rd</sup> Wednesday). Materials may also be mailed to: OB Planning Board, PO Box 7090, Ocean Beach, CA 92167 or served to a member of the OBPB Election Committee – but your affidavit and signatures must be received or postmarked on or before February 8th, 2009th to qualify. 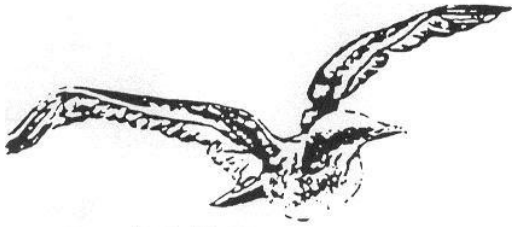
